

Transit Visa

1. REQUIREMENT

This Type of visa is issued to applicants who wish to enter the Kingdom for the following purposes:

- To travel in **transit** through the Kingdom or at the airport exceeding 12 hours in order to proceed to the country of destination or to re-entry his/her own country (category “**TS**”) requiring proof of confirmed onward ticket to Third country)
- To participate in **sport activities** (sportsmen, sportswomen, etc.) category “**S**” (requiring letter from organization concerned and invitation letter from Thailand)
- The person in charge or **crew** of a conveyance coming to a port, station or area in the Kingdom category “**C**” requiring letter from organization concerned and invitation letter from Thailand)

2. DOCUMENTS REQUIRED

- **Passport** or travel document with validity not less than 6 months after the arrival date and **MUST** not be damage. (**for non-Swedish citizen please contact the Embassy for special required**)
- **A copy of Passport** (The page(s) that shows your photo, name, date and place of birth and the expiration date of passport)-The Embassy do not provide coping service please bring your own copies.
- **Visa application form** completely filled out.
- **Two photographs**, size 4cm. x 6cm. bright background, **MUST** not be taken more than 6 months and **MUST** not be your homemade photographs.
- **A copy of itinerary** (flight detail: arriving – departing from Thailand)
- **A copy of full pre-paid** (flight confirm ticket for **the third country** you are going to)
- **A copy of valid permanent or temporary visa** of the third country where you are visiting
- **The Embassy does not provide copying or printing service.** Please always bring your own copies. The Embassy reserves the right to keep all yours document as reference after processing your visa application

3*.ADDITIONAL REQUIRE** for Passport holders of the following countries listed below who hold either permanent or temporary Swedish resident visas are required to comply with the visa process as follows: (processing time is up to 2 weeks)

Algeria, Bangladesh, Cambodia, China, Cuba, Egypt, India, Iran, North Korea, Lebanon, Libia, Nepal, Nigeria, Pakistan, Palestine, Sri Lanka, Sudan, Syria, Somalia, Vietnam, or Yemen

Applicant must prepare 3 sets of documents to submit as follow (in order)

1. **Three** completed and signed visa **Application from**
2. **Three photographs**, size 4cm. x 6cm. bright background, **MUST** not be taken more than 6 months and **MUST** not be your homemade photographs and all photos **MUST** not be different.
3. **Original passport** with (3) copies
4. **Three (3) copy of your permanent or temporary Swedish resident visas**
5. A **full- pre paid accommodation reservation** with (3) copies (showing your name, date of arrival and departure and full address of hotel reservation)
6. A **itinerary** with (3) copies (flight detail: arriving – departing from Thailand)
7. A **full pre-paid flight confirm ticket for the third country you are going to** and (3) copies
8. **Personbevis** from skatteverket (English only) with (3) copies
9. A verification **letter** (1 Original plus 2 copies) from workplace, school or university)

Please Note :

- The Embassy will **reject** your visa application if you having in completed documentthe
- visa rule and regulation may change without prior notice
- The Embassy reserved the right to requested more additional document or asking for an interview if needed
- All document that you apply for visa will not returned

******Effective from 23 February 2015******

4. VISA FEE

- 240 SEK
- Visa fee paid in **CASH ONLY** when submitting application.
- Visa fee may be changed without prior notice

5. NOTE

- **Do not apply visa earlier than 3 months** before your arrival date to Thailand.
- The Embassy will not return the fee paid for visa application in case the applicants apply visa too early than 3 months so that the applicants **MUST** check period of stay and arrival date to Thailand by yourself carefully.
- **For non-Swedish citizenship**, please contact the Embassy for actual information

6. VALIDITY OF A VISA

- The validity of a visa is 3 months for.
- The Embassy issued visa from the date you hand-in visa application.

7. PERIOD OF STAY

Upon arrival, travellers with this type of visa will be permitted to stay in Thailand for a period of **not exceeding 30 days** (subject to the discretion of the Immigration Officer at the immigration check-point)

8. VISA PROCESSING TIME:

- Applying in person or representatives:- Application will be processed and ready in 4 days (For example, if you apply a visa on Monday, your visa can be collected on Thursday afternoon excepted some certain countries and other type of visa)
Collection date for visa is specified on a payment receipt. Always bring the receipt and when collecting a visa.
- Applying through travel Agents:- Applications will be processed in 5 days
- The Embassy in Stockholm DOES NOT neither accepted nor returns visa application by post. Please contact the Royal Thai Consulate for more information www.thaiconsulate.se if you want to apply visa by post

9. VISA OPENING/COLLECTING HOURS:

- Visa applications Monday-Friday between 9.00-12.00 hours
- Collecting passport with issue visa Monday-Friday between 14.00-16.00 hours
- Closed on Thai and Swedish Publish holidays. Please check [holidays](#) list before visiting.

10. EXTENSION OF STAY

Those who wish to stay longer or may wish to change their type of visa must file an application for permission at the Office of Immigration Bureau located at Government Center B, Chaengwattana Soi 7, Laksi, Bangkok 10210, Tel 0-2141-9889 (or at <http://www.immigration.go.th>). The extension of stay as well as the change of certain type of visa is solely at the discretion of the Immigration officer.

11. REMARKS

- The Embassy will not process an un-completed visa application.
- Consular officers reserve the rights to request additional documents as deemed necessary.
- The Embassy will not return the visa fee paid after hand in your visa application
- Type of visa cannot be change after hand in your visa application.
- The applicants are fully responsible for choosing and submitting correct type of visa according to your purposes and period of stay to Thailand.
- After collecting your passport with issued visa, the applicant MUST check type of visa carefully and make sure it accords with your purposes and period of stay to Thailand.
- If there are any doubts, you MUST raise it immediately with the staff. Otherwise the applicants will take all the consequences by themselves.
- Visa requirement and information can be changed without prior notice.
